3 4	Conde	emning the hostage-taking by the Islamic Emirate of Afghanistan (IAE),
4 5	1	Calls upon the members of the United Nations Security Council (UNSC) to offer a final
5 6	1.	ultimatum peace offering to the Islamic Emirates of Afghanistan only enacted with the
7		appliance of all parties:
8		a. requiring the IEA to:
9		i. immediately release American and Japanese diplomats back to their home states safely,
10		
11 12		ii. adhere to recognizing and enacting all part of the Universal Declaration of Human Rights,
13		iii. give women the right to visit the entirety of the Afghan education system
14		and lift dress codes on them,
15		b. requiring remaining UNSC states to:
16		i. lift sanctions on Afghanistan except sanctions on the export of weapons
17		and travel restrictions on certain Afghan individuals but considers
18		reimposing them in the future, should the Afghan government not adhere
19		to the criteria stipulated in the peace negotiations,
20		ii. unfreeze parts of IEAs funds and distribute them through UNAMA to aid
21		the Afghan population in humanitarian aid efforts in cooperation with the
22		Afghan government,
23		c. willing to implement a step-by-step recognition of the Islamic Emirate of
24		Afghanistan contingent on their cooperation and commitment to past and future
25		resolutions set by the UNSC;

27	2.	Tolerates the USA's special military operation to attack certain people in charge, if
28		peace offering is not agreed upon or the hostages are not returned safely; the USA will
29		be limited to only the utmost necessary military action that does not harm citizens;
30		
31	3.	Acknowledges the need for maintaining diplomatic relationships with the IEA on the
32		basis of mutual economic benefit:

33	a. this pertains particularly to the reserves, which will be returned into the
34	ownership of IEA, allowing trade and importation/exportation of the resources
35	between any wanting members,
36	b. does not permit any member states to further occupy or freeze access of reserves
37	within the territory of Afghanistan as a form of damaging the economy, unless
38	the IEA is found to be in violation of protecting human rights,
39	i. if this is found to be true it will be the responsibility of the UN to address
40	this matter;
41	
42	4. <u>Demands</u> that from the enactment of this resolution, never again will any state or party
43	be involved in the Afghan crisis or beyond in the future use the tactic of a threat,
44	especially lethal threat, for personal gain;
45	
46	5. <u>Decides that:</u>
47	a. the IEA and Russia to return all US secret documents to their rightful owner,
48	b. the IEA keeps hold of the military Equipment for at least seven years and is
49	therefore forbidden to export said weapons;

51	6. <u>Decides</u> to remain actively seized on the matter.
